These are our plans and contact information for the Golden Isles High School Invitational Swim Meet in Brunswick, Georgia, the weekend of December 2 - 3. You will need to turn in a signed permission form and \$45 for the hotel room before our departure! Your child will need additional money for meals and any souvenirs.

Marist School mini- buses will leave at precisely 12:15 p.m.! We will be dismissed on Friday at 12:00 p.m. Team members will leave all their bags at the pool on Friday morning after practice, and go directly to the buses on dismissal. We are spending Friday night at the Jekyll Island Club Hotel on Jekyll Island—a **NICE** place (see below)! Phone numbers are listed below.

We will be stopping along the way for a light lunch. We plan to arrive by 5:00 p.m., and have some free time until about 7:30, then go to enjoy a nice, sit-down dinner. The Golden Isles Swim Meet will be on Saturday from approximately 8 a.m. – 2:00 p.m. at the Brunswick YWCA; if the weather is good we will swim in the 50-meter heated outdoor pool (and we **are** due for some nice weather at this meet!). There are no diving events, but our divers are having another meet at home. After the swim meet, we may stop in Savannah for a few hours of sightseeing before departing for home, but **we plan to arrive back at Marist at approximately 10:00 p.m. at the latest.** Last year we were back at 9:30 p.m.

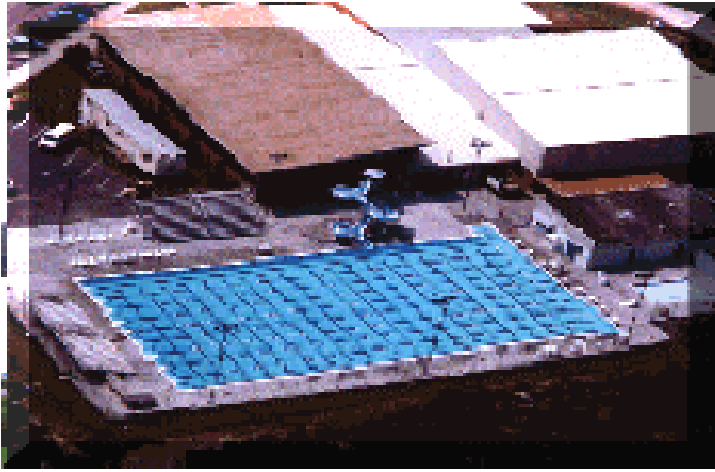
